‘RECREATED MASTERPIECES’

1. Copies of Masterpieces by living artists will not be accepted – the Master artist must have been deceased 100 years or more
2. The 'Forgery' painting must be a copy of an original painting by an Old Master and must bear the artist's signature followed by the word "after" and then the original artist's name, e.g. "Joe Bloggs, after Renoir". **Paintings must be accompanied by an A4 copy of the MASTER'S work you have copied, put into a plastic sleeve.**
3. Art Works from previous Fantastic Fakes Exhibitions can be exhibited for sale.
4. All entries must be for sale and **MUST BE THE WORK OF THE ENTRANT.**
5. Entry fee: Members No Charge Non-Members \$5 PER ENTRY
6. Size restrictions are: Small – A3 including frame; Medium – 83Hx70Wcm including frame; Large – 1 metre square including frame
7. A commission of 20% will be deducted from all sales.
8. Artist's name, address, phone number, price, title, original master's name, medium used, must be printed on back of painting.
9. Paintings in most mediums will be accepted, e.g. oil, watercolour, pastel, gouache, charcoal, pencil, computer generated etc.
10. **The entry must be a painting which is the work of the entrant and not a print or photo, nor a “painted-over” print, “painted-over” photo or “painted-over” pre-printed canvas, canvas board or similar “ground”.**
11. **More than 3** entries or paintings **larger than 120 cm x 92 cm (4' x3') (UNFRAMED)** require consent of Exhibition Committee due to space limit. **Entry form should state such a request.**
12. Entries may be framed or unframed, provided they are strung with strong cord ready to hang. Glass surfaces must be taped if delivered by courier.
13. Entries will be scrutinised to ensure framing is of a professional standard, risk-free to handle and can exhibit safely. **Frames or hanging devices requiring repair work will be rejected.**
14. **Wet paintings will not be accepted.**
15. Entries must be received during the stated times from the artist or agent in person. **Paintings will be available for collection only at the times advertised on this entry form.**
16. **Late arrivals will not be accepted.**
17. While utmost care will be exercised, neither Tilligerry Arts Group Inc. nor its members will be held responsible for insurance, loss or damage to any paintings.
18. Insurance is the responsibility of the entrant. Signing of entry form shall signify acceptance of these and other conditions of entry.
19. THE EXHIBITION COMMITTEE RESERVES THE RIGHT TO REJECT ANY PAINTING FOR ANY REASON WHATSOEVER, WITHOUT OBLIGATION TO SPECIFY THE REASONS FOR SUCH REJECTION.
20. **We may allow artworks on display to be reproduced by media during exhibitions.**
